I. <u>ADDITIONS, MODIFICATIONS, AND/OR DELETIONS TO THE</u> INSTRUCTIONS TO BIDDERS

ITEM 2:

Page IB-3, Instructions to Bidders, Section 8. Contract Time

REVISE the paragraph as shown below (added text is italicized, deleted text is shown as strike out):

"Work shall be physically completed within—180 100 working days as determined under the provisions of the Contract. Completion of Schedule A within 132nd Street SE and 134th Place SE is required by October 1, 2023. Schedule B needs to be completed within the allotted contract time."

III. <u>ADDITIONS, MODIFICATIONS, AND/OR DELETIONS TO THE</u> GENERAL CONDITIONS

Page GC-39, General Conditions, Article 20.1 Contractor's Guarantee

REVISE the first paragraph as shown below (added text is italicized, deleted text is shown as strike out):

"In addition to all other warranties, assurances, and guarantees provided in the Contract Documents, the Contractor shall guarantee the work done under this Contract against failures, leaks, and breaks or other unsatisfactory conditions due to defective equipment, materials, or workmanship for a period of one (1) year two (2) years from the date of final acceptance of the entire facility. The one (1) two (2) year period is not a contractual limitation period or limitation of other claims under or related to the Contract Documents. It is understood that partial or entire use or occupancy of the work does not constitute acceptance, but rather a benefit to the Contractor from the Owner to enable the Contractor to complete the work. Any repair work or replacement required, in the opinion of the Owner, shall be done immediately by the Contractor at the Contractor's own expense. Should the Contractor fail to repair such failures, leaks, breaks, or other unsatisfactory conditions or to make replacement within seven (7) days after written notice, it shall be lawful for the Owner to make such repairs and replacements and charge the Contractor with the actual costs of such necessary labor and material."

IV. <u>ADDITIONS, MODIFICATIONS, AND/OR DELETIONS TO THE TECHNICAL SPECIFICATIONS</u>

ITEM 1:

Page 01530-2, Specification Section 01530-Part 2, PRODUCTS

ADD the following new Section:

"2.2 PUMPING CONDITIONS

The existing system has the following approximate bypass pumping conditions:

Bypassing may occur from either the existing rock catch or 12-foot diameter surge manhole. The site has an existing above grade bypass force main connection with a 10-inch flange connection and a 6-inch Cam-Lok quick connect coupling that may be used for bypassing."

Page 02240-2, Specification Section 02240-Part 1, GENERAL

ADD the following subsection:

"1.6 PAYMENT

It is anticipated that sump and pump methods will be adequate to meet the dewatering needs for the project. This will serve as the baseline for payment under the contract lump sum bid item for "Dewatering.""

ITEM 1:

SHEET M-4, LIFT STATION REHABILITATION

Under Scope/Order of Work, **DELETE** Note 2 and **REPLACE** with the following:

"2. REPLACE PUMP VOLUTES (3), IMPELLERS (3), SUCTION PLATES (3), CHECK VALVES (3), AND ISOLATION VALVES (6). OWNER SHALL PROVIDE MATERIALS FOR CONTRACTOR INSTALLATION. CONTRACTOR SHALL ALSO REMOVE MOTORS FROM THE DRY PIT AND ALLOW TIME IN THEIR SCHEDULE SO THAT THE OWNER MAY HAVE THE IMPELLERS AND MOTORS BALANCED AT AN OFF-SITE LOCATION. COST OF BALANCING WILL BE AT OWNER'S EXPENSE AND IS OUTSIDE OF THIS CONTRACT."
