I further agree to pay the District the difference between low income senior/disabled rates and the regular rate, should it be determined that I am not qualified for low income senior/disabled rates. I further agree to provide the District with financial information to support my applications and agree to provide future income or residency information if requested by the District to verify my eligibility. I acknowledge that information provided by me in support of my application is a public record and subject to public disclosure.
